RELEASE OF LIABILITY

In consideration of being permitted to engage in the following activity - Whitley County Church Basketball League with Season and Tourney Play (hereinafter referred to as the "Activity") - which I acknowledge is supervised and unsupervised at times, I acknowledge and agree to, on my own behalf and on behalf of my personal representatives, heirs, assigns, executors, administrators, and next of kin, as follows:

1. I am aware and acknowledge that injury or death may result from my participation in the "Activity" and from the use of the premises and facilities where the "Activity" is located or is to occur, or if premises and facilities are not an applicable description, the general area where the "Activity" is to occur, and the use of any machinery, equipment, or apparatus located therein or thereon (collectively the "Activity Premises".)
2. Upon entering the "Activity Premises" I will inspect the same and my observation and my engagement, participation and/or involvement in the "Activity" shall constitute an acknowledgement that I find and accept them to be safe and reasonably suited for their intended purpose.

I hereby release Whitley County Consolidated Schools and Their Employees, Marybeth Johnson- League President, Whitley County Church Basketball League Board and Members (When applicable), Scorekeepers, Referees, and All other Players and Fans and his or her personal representatives, heirs, assigns, executors, administrators, partners, joint ventures, employees, agents, contractors and next of kin (collectively the "Releasees") from and against any and all liability for any loss, damage, injury, expenses, demand or cause of action that I may suffer whether with respect to personal injury, death damage to or destruction of property, theft, or otherwise, which may arise as a result of my presence in, upon, or about the "Activity Premises" or my use of the "Activity Premises".
4. I will indemnify and hold harmless the Releasees, collectively and individually, from any and all losses, liabilities, damages, demands, costs, causes of action and expenses that may incur, for any reason whatsoever, which may arise as a result of my participation in the "Activity", and my presence in, upon, or about the "Activity Premises" during the Church Basketball League for the years of 2016-2017.
5. I understand that I am responsible for any damages, that I, or my family members may cause to the "Activity Premises", whether by accident or intentional harm to such "Activity Premises". I will pay for any and all damages that myself, or my family may cause.

I also have read a copy of all four pages of the Rules and Regulations/Waiver of Liability form of the League, and promise to abide by them, and will act in a responsible manner as a member of the Church League. RULES AND REGULATIONS FOR USE OF FACILITIES - Set per contract with W.C.C.S.

These rules are given to us by the school, they are in addition to our regular league rules. We need to abide by these to keep the privileges of the use of the gym. If these rules are broken, we could lose the privilege of the use of the gym. Users must take reasonable steps to ensure orderly behavior and will be responsible for all damage associated with their use of the facility or equipment.

1. **No children or adults are allowed to be playing or running in the hallways of the school. Please do not bounce balls in the hallways either. ALL CHILDREN/TEENS MUST HAVE AN ADULT SUPERVISOR ESCORT THEM TO THE BATHROOM! PARENT PLAYERS, whose children are found in the hallways without escorts, will have to be dismissed from the league.**
2. **Spectators ARE NOT allowed to have drinks in the gym.**
3. **YOU MUST HAVE BASKETBALL SHOES! You MAY NOT wear your basketball shoes in from the outdoors. Anyone who is found with shoes that have been worn outdoors, will not be allowed to play. (We want to keep the floor as nice as possible.)**
4. **Use of tobacco is prohibited on the premises.**
5. **Alcoholic beverages and controlled substances will not be permitted on corporation property at any time.**
6. **Gambling of any kind is prohibited.**

CHURCH BASKETBALL INDIVIDUAL LEAGUE RULES

1. You must be a Freshman in high school in order to play in this league, with a minimum age of 14.
2. Two dollars per person per game, must be paid before game starts. If your team forfeited the week before, each team member will have to pay \$5.00 the following week.
3. **One organized church service per week at your local church is required to play ball the following week. We will be checking church attendance randomly throughout the year.**
4. First team listed will be Home Team, and they will be responsible for the devotional and prayer before the game, they will also have choice of shirt color if duplicate colors are playing each other. **Both teams of first and last games need to help with any set up or clean up as designated per coaches meeting.**
5. Two twenty-minute halves with a 5 minute half-time. Two time outs per half. They do not carry over.
6. Last three minutes of each half, the clock will stop on every whistle. However, if at the last 3 minutes (in the second half) if one team is ahead by 20 points or more the clock will continue to run on the last 3 minutes of the second half.
7. Overtime will be three minutes with clock stopping on every whistle. On **double** overtime, the clock will only stop on the **last minute** of the three minute overtime. Each team will receive an additional time out.
8. IHSAA Rules will apply with the following exception: You will be out of the game on the 6th foul, not the 5th foul committed. Please be reminded that technical fouls count as personal fouls.
9. Players must have at least 4 games to be eligible for the tournament. (Injuries, Military Duties, and other Exemptions will be handled by the league director.)
10. All players must have the same color shirts with numbers.
11. In the tournament, if a team knows they will have to forfeit a game and they are in the loser's bracket, the other team will automatically move up and continue on in tournament play.

12. Once your name is on a roster for a team, you MAY NOT play for another church in the league. **NO EXCEPTIONS - PLEASE DON'T ASK!** However, if your church has two teams in the league – you may move players from your team if 5th- 7th player is needed, to keep us from having a forfeit. An individual player, is only allowed to move two weeks through the season. **NO** moves are allowed to be made during the tournament. If a player plays in more than one game in a given week, this does not count as an extra game toward eligibility of tournament.

13. Foul language **will not be permitted** in this league. If you choose to use such words, you will have a **Level 1 Technical Foul** called on you, and will have to sit out of the game for a **5 minute penalty**. During that five minute penalty you will need to sit by the score table, and you will need to sign a 5 minute penalty warning form. (Please be reminded, that while sitting in the 5 minute penalty, this does not give you time to voice your complaint to the scorekeeper.) If by chance, your first offense takes place in the last 5 minutes of the game, you will automatically sit **an additional Five Minutes** in the next game you play in. **On your second offense** of the season, whether in the same game, or another game, the offense will be cause for **expulsion** of that game. **You will need to leave the school building immediately for the rest of the day!** If you choose not to leave the school building, you will be **suspended from the league, and will forfeit any and all individual awards that you may have forth coming.**

14. A derogatory comment made towards a referee or scorekeeper could constitute a **Level 1 Unsportsmanship Technical Foul**. If a **Level 1 Unsportsmanship Technical Foul is called**, you will have to sit out of the game for a **5 minute penalty**. During that five minute penalty you will need to sit by the score table, and you will need to sign a 5 minute penalty warning form. (Please be reminded, that while sitting in the 5 minute penalty, this does not give you time to voice your complaint to the scorekeeper.) If by chance, your first offense takes place in the last 5 minutes of the game, you will automatically sit **an additional Five Minutes** in the next game you play in. On your second offense of the season, whether in the same game, or another game, the offense will be cause for **expulsion of that game and a one game suspension**. **You will need to leave the school building immediately for the rest of the day!** If you choose not to leave the school building, you will be **suspended from the league, and will forfeit any and all individual awards that you may have forth coming.**

15. **A Level 2 Unsportsmanship Technical Foul** will be an **IMMEDIATE EXPULSION** from the game. On such case, **You will need to leave the School Building IMMEDIATELY!** A **Level 2 Unsportsmanship Technical Foul** will be at the **official's digression**. This can be for any action that the official feels is detrimental to the standards of this league.

16. If at anytime during the season, or tournament, a player **has extended his grace to the need of expulsion from any game**, a meeting will be set up with the director, coach, and player, before they can play their next game. A written letter will be signed by all three in attendance, stating that the player understands that **they will be suspended** for the rest of the season, tournament play, and will forfeit any individual award money, if they choose to act in a manner that would present themselves with a **THIRD UNSPORTSMANSHIP TECHNICAL FOUL (Level 1 or / and 2)**. **NO EXCEPTIONS - PLEASE DO NOT ASK!!!!**

17. In the event that a player or players would advance towards another player, or official in a threatening manner (verbal or physical), a **Level 3 Technical Foul** will be called automatically and **IMMEDIATE SUSPENSION FROM THE LEAGUE AND TOURNAMENT WILL TAKE PLACE!** If you are suspended from the league, you also forfeit any individual awards that you may have forth coming.

18. **ALL PLAYERS AND COACHES WILL BE REQUIRED TO SIGN A WAIVER RELIEVING WHITLEY COUNTY CONSOLIDATED SCHOOLS, MARYBETH JOHNSON, LEAGUE BOARD, SCOREKEEPERS, REFEREES, OR OTHER PLAYERS IN THE LEAGUE - FROM ANY AND ALL LIABILITY FOR ANY AND ALL ACCIDENTS.** All players will need to turn in a Player Information Sheet, with their signed waiver of liability, and knowledge of printed rules. All coaches must witness their player's signatures.
